Minutes of a Development, Planning, Highways and Safety Committee Meeting held on Wednesday 18 July 2012 at the Town Council Office, 60 Welton Road, Brough

Public Forum: PCSO Barbara Danby attended the meeting to speak on issues along Saltgrounds Road and the Haven. She spoke of a petition that is currently being circulated by residents in support of traffic calming which so far contains 400+ signatures. The Police/Traffic Police have checked out complaints about speeding and anti-social behaviour by carrying out vehicle checks and visiting parents. The Haven is now covered by CCTV (courtesy of BAE) and the Police are monitoring it. A gate is to be installed at the Haven and will be locked overnight.
