**3. TO ACCEPT MINUTES OF THE VILLAGE ENVIRONMENT MEETING HELD ON 18 SEPTEMBER 2013**

It was proposed by Councillor Davis, seconded by Councillor Mrs. Galbraith and agreed unanimously that the minutes of the meeting held on 18 September 2013 be signed as a true and accurate record of the meeting.

**4. ELLOUGHTON-CUM-BROUGH IN BLOOM**

Councillor T. Galbraith reported that Elloughton-cum-Brough in Bloom had been disappointed at not achieving gold in the Yorkshire in Bloom competition, despite all the hard work undertaken prior to the judging. It was undecided whether they will enter again. In the meantime they have invited the head groundsman at ERYC to the next meeting for advice.

**5. MATTERS RELATING TO FOOTPATHS**

**5.1 Dog Fouling – Peggy Farrow Lane**

Correspondence had been received from a resident complaining about the amount of dog mess along Peggy Farrow Lane, however Councillor Davis had recently walked the path and found it not to be too bad.

Complaints had also been received about dog mess along Main Street and Elloughton Road. A resident had taken stencils and spray paint also stickers which have been placed on bins within the vicinity.

This matter was also highlighted to Justine who has posted it onto the Petuaria Press Facebook page.

**6. MATTERS RELATING TO PLAY AREAS**

**6.1 Trees/CCTV**

It had been reported that tree branches were obscuring the CCTV cameras and a quote for £50 had been received to cut back around the cameras.

It was agreed unanimously to go ahead with the quote.

**7. MATTERS RELATING TO STREET FURNITURE**

The glass in the notice board on Centurion Way had once again become clouded. The matter is to be investigated with a view to possibly replacing the glass.

**8. MATTERS RELATING TO OPEN SPACES**

**8.1 Petition – Coronation Copse**

A petition had been received requesting that Coronation Copse either be cut down or cut right back for pedestrian and traffic safety.

It was noted that the majority of the petitioners did not live within the immediate vicinity of the copse and some did not live in Brough or Elloughton.

Nigel Robson (ERYC Highways and tree Manager) visited the site and found that the trees did not encroach onto the footpath or highway and there was no obstructions to pedestrian or highway sight lines. Therefore he felt there is no reason to fell or prune the trees or to remove any of the growth from around the lower trunks as it is part of the feature of these types of trees. He noted that the trees are not too big for their location and form a valuable part of the street scene.

Although there is no danger to pedestrians, he suggested that three pieces of deadwood might be removed from inside the copse and arrangements have been made for this to be undertaken.

Councillor Galbraith also inspected the site and reported there is good clearance between the trees and houses.

It was felt that Coronation Copse forms an important part to the street scene and it was agreed to follow the advice of the tree officer.

**9. PRECEPT 2014**

Following discussion, it was agreed unanimously that the precept be increased by £2,000 to £16,000.
